The Ekashila Educational Society has applied for according permission to open classes Nursery to X (E.M), Ekashila Advanced Learning School, Door No:3-3, Islam Nagar, Cherla Gouraram(V), Kanagal(M), Nalgonda Dist vide reference 2<sup>nd</sup> cited.

The District Educational Officer, Nalgonda Dist has caused inspection and submitted the report in the reference 3<sup>rd</sup> cited.

The Govt. vide reference 5<sup>th</sup> cited has accorded permission to open Nursery to X (E.M) from the academic year 2023-2024 in respect of Ekashila Advanced Learning School, Door No:3-3, Islam Nagar, Cherla Gouraram(V), Kanagal(M) Nalgonda Dist and the DSE, TS, Hyderabad has communicated the same and requested to take action accordingly.

In view of the above, the Management of Ekashila Advanced Learning School, Door No:3-3, Islam Nagar, Cherla Gouraram(V), Kanagal(M), Nalgonda Dist is hereby permitted to start the school with classes Nursery to X (E.M) from the year 2023-2024 besides the following conditions in the reference 1<sup>st</sup> cited.

1. That the society shall abide to the rules and regulations made in the Govt. orders 1<sup>st</sup> cited above.
2. That the Society shall provide the necessary amenities like accommodation sanitary facilities, drinking water facilities, furniture, Library, Laboratory, equipment play field required staff as per the staff pattern and other facilities before approaching the competent authority.
3. That the Society shall apply for recognition by immediately at the latest duly fulfilling the conditions.
4. That the permission is accorded is restricted to this year only and it is not valid for the subsequent academic year.
5. That this permission does not confer any right on the society for claiming recognition.
6. That the permission is accorded to the Ekashila Educational Society /Trust and no other society/Trust of body can open a school on their behalf.
7. The permission is accorded to open to the school permission in the locality there shall not be a change in the premises of locality.

8. The society shall provide the necessary material even if it costs more than the deposit amount.
9. Proper and adequate parking area for vehicles shall be provided transporting the children to and from the school.
10. Proper and adequate sanitation facility shall be provided for students especially for girl students.
11. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
12. The school shall follow the traffic and safety guidelines indicated by the police and fire services departments.
13. The Parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
14. The school shall have first aid kit and the teachers shall be trained in first aid.
15. The above permission is accorded purely on a temporary basis and is subjected to the reports of State Level Inspection and Vigilance Committee fulfilling of all the prerequisite condition under the A.P Education Act 1982 and if later found that the school has not fulfilled any prerequisites as stipulated, the permission now being given is liable to be withdrawn at once.
16. The permission is accorded for classes Nursery to X (E.M) with single sections only (Each class) and further the management shall have no right to put any branches with this permission order.
17. The Management has to follow the Government norms from time to time, for collection of fee from students.
18. The management should deposit by the way of NSC or Kisan Vikas Patra an amount of Rs. 50000/- and pledge with the DEO, concerned towards endowment fund as per Sub Rule (1) of Rule (5) of G.O.Ms.No. 1, Edn, PS (2) dept, dt: 01.01.1994.
